

# CERTIFICATE OF INSURANCE

## TO WHOM IT MAY CONCERN

THIS IS TO CERTIFY that **We, BULSTRAD VIENNA INSURANCE GROUP**, No.5 "Positano" Sqr., 1000 Sofia, **Republic of Bulgaria**, have placed Insurance with certain **Insurance Companies** and **Lloyd's Insurance SA Underwriters** on the **International Insurance & Reinsurance Market** in the name of **"CARGO AIR" LTD. – Bulgarian Aviation Company** as Owners and/or Operators and/or Associated and/or Subsidiary and/or Affiliated Companies now existing or as may be hereafter constituted, jointly and severally for their respective rights and interests (hereinafter called the **"Insured"**) covering their operations in connection with the following Aircraft:

Type of Aircraft: **Boeing B737-300, M.S.N. 23970. MTOW 63,276 kg., reg. sign LZ-CGP**

whilst Flying and/or Taxiing and/or on the Ground, **Worldwide**, against risks and up to the limits stated:

**1/ AIRCRAFT HULL & SPARES "ALL RISKS"** – to cover loss or damage to the Aircraft (including Engines and APU installed on board) for an Agreed Value in **USD**. The coverages provided are subject to and in accordance with the content of **Hull & Spares "All Risks" Insurance Policy** (specified below).

**2/ AIRCRAFT LEGAL LIABILITY COVERAGE - COMBINED SINGLE LIMIT of USD 600,000,000**, including Aircraft Liability to Third Parties (Bodily Injury / Personal Injury / Property Damage / Products & Grounding Liability) of not less than **SDR 300,000,000** and in the annual aggregate in respect of Products Liability: Liability to Passengers (non-revenue occupants /cargo handlers/ loadmasters only) up to **SDR 250,000** per passenger (coverage provided for up to 6 pax seats on board); Cargo and Mail Legal Liability Limit up to **USD 5,000,000** any one occurrence, but not less than **SDR 22** per kilogram. In addition, the coverage is extended to include Crew Personal Accident up to the Limit of **USD 300,000** any one crew seat, when engaged in "Air Travel". Carriage of declared values, livestock and perishables are **EXCLUDED** from Coverage/. Coverage also includes War and Allied Risks in accordance with the Extended Coverage Endorsement (Aviation Liabilities) **AVN.52E** with the Sub-limit of **USD 600,000,000** and in the annual aggregate, however the Sub-limit shall not apply to Cargo, Mail, Passengers and Passenger Baggage whilst on board an Aircraft. The Coverages provided allows carriage of "Dangerous Goods", subject to (i) the Aircraft is operated in accordance with its valid Certificate of Airworthiness, Air Operator Certificate or permit to fly, (ii) all Air Navigation Regulations are completed and (iii) carriage of such goods is in accordance with **IATA / ICAO** regulations and/or requirements of the appropriate Civil Aviation Authority (iv) all necessary permissions for such flights are obtained prior such flights. The Policy contain standard General Exclusions relating to Pollution and Contamination Risks as noted in Noise and Pollution and Other Perils Exclusion Clause **AVN.46B** and Nuclear Risks, covering carriage of goods / materials as noted in par. 2 and par. 4 of Nuclear Risks Exclusion Clause **AVN.38B**. The coverages provided, are subject to and in accordance with the content of **Aviation Liability Insurance Policy** (specified below).

The coverages provided above **EXCLUDES** Official War Areas and/or Countries / Regions under **United Nations** sanctions and/or Countries/ Regions as per Kiln Geographic Areas Exclusion Clause LSW.617H (09/07/15), amended to **EXCLUDE** also: **Libya, Ukraine, Russia inc. Crimea, Belarus, Israel and Jordan** including overflying these areas / Countries / Territories.

It is hereby Certified that We, as **Insurers** have been advised that the above noted Aircraft, which will be operated by the **Insured** (as **Lessee** and **Aviation Operator**) is subject to the following **Contracts**: (i) **Aircraft Dry Lease Agreement** dated 15<sup>TH</sup> December 2009 signed with **Air Vega Bulgaria JSC.** (as **Owner** and **Lessor**). It is further noted and agreed to include the above noted **Contract Party** as **Additional Insured** for their respective rights and interests, subject to the Agreements signed by and among the **Insured**.

Box 3707, Mail Code 21-34, Seattle, Washington 98124-2207, U.S.A.**, (hereinafter called "**Boeing**"). In accordance with Customer's undertaking in Part I, Article 13.1 of the **CSGTA** it is further noted and agreed that "**Boeing**" are included as **Additional Insured** for their respective rights and interests.

Date Recognition Exclusion Clause (**AVN.2000A**) written back in accordance with the Date Recognition Limited Coverage Clauses (**AVN.2001A/AVN.2002A**) as applicable.

Subject to the terms, conditions, deductibles, limitations, exclusions, cancellation and other provisions of relative **Hull & Spares "All Risks" Insurance Policy No. 02050000262410000003** and **Aviation Liability Insurance Policy No. 02110000262410000004**, both valid as from 00:00 hrs LST on 7<sup>TH</sup> February 2024 until 24:00 hrs LST on 6<sup>TH</sup> February 2025, issued by **BULSTRAD VIENNA INSURANCE GROUP** in the name of **CARGO AIR LTD.**

**The coverage provided shall not contravene any applicable U.N. Sanctions as well as Sanctions and Embargo AVN.111 Clause**
